RULES AND CONDITIONS

For the comfort, benefit, security, and safety of all the users of the facilities, users are asked to co-operate with the King's Bastion Leisure Centre Staff to ensure that the following rules and conditions of use are effectively enforced.

RULES AND CONDITIONS OF USE

It is our objective to make the king's Bastion Leisure Centre a fun and safe place for all the family, where people of all ages can enjoy the amenities in a relaxed environment. In order to help Management achieve this:-

- No person deemed to be under the influence of alcohol and / or drugs will be allowed within the centre.
- Users are expected to act in a manner that does not cause a hazard or annoyance to other users or a danger unto themselves.
- Users are expected to respect and abide by the no-smoking and alcohol consumption rules, and any other rules as may govern the use of particular areas, for example the Ice Skating Rink and Youth Lounge.



- Vandalism of furniture, equipment, fittings or any other part of the Centre and Bastion will not be tolerated.
- Centre Managers are on duty at all times to supervise the facilities, enforce these Rules and to assist users of the facilities. All users are expected to comply with the lawful instructions that may be given by the Centre Staff.
- CCTV surveillance will be in operation throughout the Centre, and Uniformed Security Guards are also on duty to supervise the use of the facilities and to assist in the enforcement of these Rules. Users must comply with any security instructions which may be given by Security Staff and / or Management.
- Any user who wilfully fails to comply with any of the above Rules, or who obstructs a member of the Centre Staff in the execution of their duties, is liable to be asked to leave the Centre.
- Serious and / or repeated non-compliance with these Rules will render a person at management discretion, liable to be banned from using and/or entering the Centre.
- Please help keep the Centre clean. All areas are provided with bins for you to dispose of your litter and thus ensure the cleanliness of the facilities.

SMOKING AND ALCOHOL CONSUMPTION

- No smoking is allowed inside the Centre building.
- Designated smoking zones are provided on the outdoor terraces and esplanade. The Youth Lounge is strictly a non-smoking and no-alcohol zone.
- Alcoholic drinks may be consumed only by persons over the age of 18 and only in designated seating areas.
- Consumption of alcohol, therefore, whilst walking around the Centre or whilst Ice Skating, or using the Internet Lounge, Entertainment Arcade and other facility areas is not permitted.
- The co-operation of users in reporting to Centre Staff any acts of vandalism or misbehaviour would be greatly appreciated.
